Undersigned (as User) hereby acknowledge / declare:

- there is a risk of serious injury during the activity, which may cause even death;
- I acknowledge that I, myself, bear the risk of any damage which is part of the normal risk normally related to the particular sports activity, as a risk voluntarily assumed by participating in the sport;

- I have read, accept and acknowledge the FLOW Boulder's policies as binding;
- FLOW Boulder shall not be liable for any injuries or damages that do not result from the use of equipment or devices provided by FLOW Boulder, nor for collisions with third parties (climbers or visitors);
- after using and leaving the facility, I shall not claim compensation for any physical/mobility injury, such as: sprains, lumbar sprains, etc., in the absence of an official accident report taken on the spot;
- I shall not make a claim for mental health problems against FLOW Boulder (such as: developing a fear of heights, anxiety symptoms, etc.);
- I shall promptly reimburse the damages caused by me to FLOW;
- in the event of intentional damage to or theft of FLOW Boulder property/equipment, FLOW Boulder may file a police report, regardless of the amount, for intentional risking of third parties;
- I have full knowledge of the safe use of the equipment used in the climbing gym;
- I use the FLOW Boulder climbing gym and its equipment at my own risk;
- FLOW Boulder shall not be liable for any personal injury or property damage resulting from the use of the climbing gym and its equipment;
- smoking, open flame; littering; any dangerous activities are strictly prohibited in the climbing gym. It is prohibited to use the climbing wall under the influence of drugs, alcohol or medicines (!);
- any problems with the wall, handholds, tools, equipment or the behaviour of others must be promptly reported to the operating staff;
- FLOW Boulder shall not be liable for any damages that I unlawfully, intentionally or by gross negligence (including, without limitation, under the influence of alcohol, drugs or intoxicating substances);
- I consent to that I may be included in photographs taken at the climbing gym, training sessions and events, and that they may be reproduced or published in electronic or printed form.
